PREAMBLE

POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK is a higher institution address **Jalan 28 Oktober, Siantan Hulu, Pontianak Utara, Kota Pontianak, Kalimantan Barat 78241, Indonesia**

LINCOLN UNIVERSITY COLLEGE (LUC), one of the most renowned universities in Malaysia, with the present postal address **Wisma Lincoln, No 12-18, Jalan SS 6/12, 47301 Petaling Jaya, Selangor, Malaysia**

Hereby conclude a Memorandum of Understanding for joint activities to promote understanding and friendship to further education and collaborative research. Both institutions will encourage and facilitate these exchanges of activities, consistent with the goals and objectives of each institution, availability of personnel, space and materials guided by the rules and regulations of governing bodies of each country.

ARTICLE 1:
JOINT DEGREE PROGRAMME :

POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK

AND
LINCON UNIVERSITY COLLEGE MALAYSIA

POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK has agreed has agreed to conduct program based on MQA approved curriculum :

1. Master in Nursing
2. PhD in Health Science
3. Top up degree
4. Student Exchange – study tour
5. International seminar

ARTICLE 2: TEACHERS EXCHANGE PROGRAMMES

POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK and LUC will encourage teachers exchange for the purpose of gaining experience and some informal training. The details of the expenses of each programme will be elaborated based on the nature of the programme **POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK** to establish regional centers on campus LUC to running its own operating program or program in collaboration with LUC

ARTICLE 3: TEACHING AND LEARNING MATERIALS

Both institutions will encourage collaborative development of learning and teaching materials in electronic and conventional form, form and in the form of hard copies, There will be a potential exchange of specimens/ models and pictures including slides, collaborative professional consultancy on diagnostic procedures such as second opinion will be done through various telemedicine technologies and the development of on line lectures and tele-video conferencing. Similar cooperation on other basic and clinical sciences disciplines shall also be encouraged.

ARTICLE 4: RESEARCH AND DEVELOPMENT

POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK and **LINCOLN UNIVERSITY COLLEGE MALAYSIA** shall encourage collaborative research and joint supervision of graduate students among their staff on areas of common interest and shall include the employment of research facilities at both institutions.

ARTICLE 5: STAFF AND FACULTY DEVELOPMENT

Each institution will encourage the organization of joint academic discourse on teaching skills (e.g. communication skills, MCQs and MEQs) and joint workshops on research (methodologies, paper writing, data collection etc) and there will be joint efforts to establish a curriculum which incorporates ethics / character building for undergraduate and postgraduate education and training.

ARTICLE 6: VISITING/ EXTERNAL EXAMINERS

Both institutions will encourage the sharing of experience through staff visits and appointment of external examiners/assessors and invited lecturers to strengthen each other's academic program. There will be provisions for invitation of external examiner from each institution for the professional examinations in appropriate programs. These will also encourage the examiners to be invited lecturers for the topics of their expertise.

ARTICLE 7: TERM AND TERMINATION

This memorandum shall be in effect on 8th May 2017 and shall continue in effect for a period of 1(one) year from the date of this memorandum and is renewable thereafter for yearly terms subject to revision and mutual written consent.

Either party may terminate this memorandum by giving three (3) months notice to the other party in writing, if they can't perform in 1(one) year the memorandum will be terminated unless an earlier termination date is mutually agreed. Such termination will not adversely affect any student currently enrolled of any stage of the joint program.

Each party will ensure that adequate arrangement is made to complete all commitment before the memorandum is terminated.

ARTICLE 8: PRINCIPAL CONTACTS FOR THE AGREEMENT

At **POLITEKNIK KESEHATAN KEMENTERIAN KESEHATAN PONTIANAK** the responsible parties for administering this partnership program shall be the Rector of University or his/her designee.

At **LINCOLN UNIVERISTY COLLEGE** the responsible parties for administering this partnership program shall be the Deputy Vice Chancellor of Corporate Office or his/her designee.

ARTICLE 9: NON BINDING

Both parties are not legally bound to any terms as stipulated in this memorandum. Any proposals or agreement between the institutions on other matters of collaboration will be subject to specific approval, and will be agreed by a further agreement or in new additional clause.
